# **Course Description and Objectives**

Evaluation is the systematic assessment of policies and programs designed to improve social conditions. Evaluators apply social science research methods to answer key questions about the performance of such programs. Evaluation is a major tool for policy analysis, assessment and decision making. This course examines many facets of the evaluation process, including the purposes and types of evaluations, strategies, methodology, and applications. The course will also consider how evaluations are shaped by social and political contexts. Upon successful completion of this course, students will be able to:

- Explain fundamental theory and techniques of policy and program evaluation
- Collect, analyze, and interpret data
- Apply appropriate evaluation methods and interpret results
- Synthesize and critique qualitative and quantitative evidence
- Describe cultural, political, economic, and social justice implications of evaluation
- Produce and report policy and program evaluation research and results to public policy decision makers and the public

# Course Approach

Our meetings will take place online weekly as scheduled. **This course is not self-paced.** Students are expected to meet specific due dates listed in the Class Schedule section of this syllabus. It is the student's responsibility to keep track of the weekly course schedule of topics, readings, activities and assignments due. **Participation:** Students are encouraged to actively engage in all course activities throughout the semester, which include viewing all materials, completing activities and assignments, and participating in class discussions and group interactions. Students will be fully prepared for each class session, demonstrate knowledge of assigned readings and provide thoughtful responses to discussion questions and exercises. A portion of each class will be devoted to practical application of the course concepts utilizing evaluation methods and tools, with students alternating as group leaders for hands-on work.

Attendance: Students are expected to attend all class sessions. Schedule conflicts must be discussed with the instructor in advance. Students must be connected to the internet with the computer's camera on for the entire session: students not visible to the instructor will not be considered in attendance.

Assignments must be submitted via Canvas on the scheduled due date to receive full credit. Due dates for assignments are listed in the course outline. Late assignments will only be accepted or graded with prior written approval from the instructor.
