This course, Peace Operations: Theory and Practice, will be a survey course that will combine theory and the practical aspects Peace Operations.

Course Objectives

- Familiarize students with terminology and concepts of Peace Operations
- Help students to think systematically and analytically about Peace Operations
- Connect theory to practice through discussion and case studies of real events and operations

Course Requirements

<u>Attendance and participation (15 points)</u>: Regular attendance is extremely important and absences will affect your grades and may even result in failure. Discussion is critical to student learning and to exhibit that the required reading is being completed. Should you not be able to attend a class over the course of the semester because of an unforeseen emergency, please discuss with me.

<u>Blackboard Weekly Updates (10 points)</u>: The updates should draw-upon the material covered in the previous class and should be submitted before the next class. The first update should provide background about the conflict.

The fourth text is - USIP, 2009, *Guiding Principles For Stabilization And Reconstruction*, USIP Press. Specific readings will be assigned during the course of the semester. You should be able to get this for free.

I will add to the Library reserves or post on blackboard a few contemporary articles, as well as texts of some recent Security Council resolutions. I will also ask students to watch a few video clips.

Process: The classroom times will be used to present an overview of the topic areas and to highlight additional readings. Full lectures will be the exception rather than the norm. This class will be run as a participative seminar; we expect candid and frequent participation from every student. But remember: Emotional arguments are less meaningful than factual ones. Back up your opinions.

Correspondence Course: This semester we will be including a correspondence course from the Peace Operations Training Institute (POTI) as part of the requirements. <u>The History of United Nations</u> <u>Peacekeeping Operations from 2000–2020</u>. The course must be completed and a photocopy of the graded certificate turned in no later than November 11, 2025.
